## Example: ST or SW

- We know that:

90\% of the ST fans likes Tea, 30\% of the SW fans likes Tea.
And
the ratio of ST fans vs SW fans = 1:9.

- What is the probability that a person is a ST fan if we find out that he/she likes Tea?


## ST or SW (mathematical formulation)

- Two-way classification

A: A1=Tea or A2=Coffee (not Tea) .
B: $\mathrm{B} 1=\mathrm{ST}$ or $\mathrm{B} 2=\mathrm{SW}$

- Model Probability (Likelihood, CPT):

90\% of the ST fans likes Tea, $\operatorname{Pr}($ Tea $\mid$ ST $)=0.9$
30\% of the SW fans likes Tea
$\operatorname{Pr}($ Tea $\mid$ SW $)=0.3$

## ST or SW (mathematical formulation)

- Prior or Marginal Probability

The ratio of ST fans vs SW fans = 1:9 $\operatorname{Pr}(S T)=0.1$ and $\operatorname{Pr}(S W)=0.9$

- Posterior Probability (inverse probability)
What is the probability that a person is a ST fan if we know that he/she likes Tea?

$$
\operatorname{Pr}(S T \mid T e a)<-\operatorname{Pr}(T e a \mid S T) \text { etc }
$$

## ST or SW (solution)

- Given the model probability and the prior probability, we must find the posterior probability.
- We know:

$$
\begin{aligned}
& \operatorname{Pr}(T e a \mid S T) \text { and } \operatorname{Pr}(T e a \mid S W) \\
& \operatorname{Pr}(S T) \text { and } \operatorname{Pr}(S W)
\end{aligned}
$$

- Using Bayes Theorem, we can calculate the posterior probability as


## ST or SW (joint frequency table)

- Suppose that we know the Joint Frequency

|  | Cross Table |  |  | Marginal Freq |
| :---: | :---: | :---: | :---: | :---: |
|  |  | sw | st |  |
|  |  | B1 | B2 | marginal |
| tea | A1 | 270 | 90 | 360 |
| coffe | A2 | 630 | 10 | 640 |
|  | marginal | 900 | 100 | 1000 |

- Then, it is easy to calculate the desired

Posterior Probability as the row conditionals.

```
Pr(ST | Tea) = 90 / 360=0.25
Pr(SW | Tea) = 270 / 360=0.75
Pr(ST | Coffee) = 10/640=0.984
Pr(SW | Coffee) = 630/640=0.016
```


## ST or SW (joint probability table)

- Joint Probability Table
joint prob = joint frea / total

|  | Joint Probability P(A,B) |  |  | Marginal P <br> $\mathrm{P}(\mathrm{A})$ |
| :---: | :---: | :---: | :---: | :---: |
|  |  | sw | st |  |
|  |  | B1 | B2 |  |
| tea coffe | A1 | 0.27 | 0.09 | 0.36 |
|  | A2 | 0.63 | 0.01 | 0.64 |
|  | P(B) | 0.9 | 0.1 | 1 |

- Posterior Probability as the row conditional

Posterior Probability $\mathrm{P}(\mathrm{B} \mid \mathrm{A})$
tea
coffe

| sw |  |  |  |  | st |
| :--- | ---: | ---: | ---: | :---: | :---: |
| A1 | B1 | B2 | sum |  |  |
| A2 | 0.750 | 0.250 | 1 |  |  |

## ST or SW (how to calculate joint)

- Joint Probability $\operatorname{Pr}(A i, B j)$ from Model Prob $\operatorname{Pr}(\mathrm{Ai} \mid \mathrm{Bj})$ and $\operatorname{Prior} \operatorname{Pr}(\mathrm{Bj})$

$$
\operatorname{Pr}(A i, B j)=\operatorname{Pr}(A i \mid B j) \times \operatorname{Pr}(B j)
$$

$\operatorname{Pr}($ Tea, $\quad S T)=\operatorname{Pr}($ Tea $\mid S T) \quad \times \operatorname{Pr}(S T)$
$\operatorname{Pr}($ Tea, $\quad S W)=\operatorname{Pr}($ Tea $\mid S W) \times \operatorname{Pr}(S W)$
$\operatorname{Pr}($ Coffee,$S T)=\operatorname{Pr}($ Coffee $\mid S T) \times \operatorname{Pr}(S T)$
$\operatorname{Pr}($ Coffee, SW$)=\operatorname{Pr}($ Coffee $\mid S W) \times \operatorname{Pr}(S W)$

- Marginal Probability Pr(Ai)
$\operatorname{Pr}(A i)=$ sum over $B j$ of $\operatorname{Pr}(A i, B j)$
- Posterior Probability $\operatorname{Pr}(\mathrm{Bj} \mid \mathrm{Ai})$

$$
\operatorname{Pr}(\mathrm{Bj} \mid \mathrm{Ai})=\operatorname{Pr}(\mathrm{Ai}, \mathrm{Bj}) / \operatorname{Pr}(\mathrm{Ai})
$$

## ST or SW (joint probability table)

Conditional Probability $\mathrm{P}(\mathrm{A} \mid \mathrm{B})$

| SW |  | st |
| :--- | ---: | ---: |
|  | $P(A \mid B 1)$ | $P(A \mid B 2)$ |
| $A 1$ | 0.3 | 0.9 |
| $A 2$ | 0.7 | 0.1 |
| sum | 1 | 1 | coffe


| Joint Probability P(A,B) |  |  | Marginal P |
| :---: | :---: | :---: | :---: |
|  | SW | st |  |
|  | B1 | B2 | $\mathrm{P}(\mathrm{A})$ |
| A1 | 0.27 | 0.09 | 0.3 |
| A2 | 0.63 | 0.01 | 0.6 |
| P(B) | 0.9 | 0.1 |  |

Posterior Probability $P(B \mid A)$
Prior Probability of $B(P(B)$


| SW |  |  |  |
| :--- | ---: | ---: | ---: |
|  | B1 | B2 | sum |
| A1 | 0.750 | 0.250 | 1 |
| A2 | 0.984 | 0.016 | 1 |

## Bayes Theorem

Bayes Theorem
Let $A_{i}, i=1,2, \ldots, a$, and $B_{j}, j=1,2, \ldots, b$ be the two-way classification of the result of an experiment and assume that $A_{i}$ and $B_{j}$ are mutually exclusive and exhaustive. Let $\operatorname{Pr}\left(A_{i} \mid B_{j}\right)$ be the conditional probability of $A_{i}$ given $B_{j}$, and $\operatorname{Pr}\left(B_{j}\right)$ be the marginal probability of $B_{j}$.
Then, the conditional probability of $B_{j}$ given $A_{i}$ can be given as

$$
\begin{equation*}
\operatorname{Pr}\left(B_{j} \mid A_{i}\right)=\frac{\operatorname{Pr}\left(A_{i} \mid B_{j}\right) \operatorname{Pr}\left(B_{j}\right)}{\sum_{j=1}^{b} \operatorname{Pr}\left(A_{i} \mid B_{j}\right) \operatorname{Pr}\left(B_{j}\right)} \tag{1}
\end{equation*}
$$

## Conditional and Joint Prob

Conditional Probability

$$
\begin{equation*}
\sum_{i=1}^{a} \operatorname{Pr}\left(A_{i} \mid B_{j}\right)=1 \quad \text { and } \quad \sum_{j=1}^{b} \operatorname{Pr}\left(B_{j} \mid A_{i}\right)=1 \tag{2}
\end{equation*}
$$

Joint Probability and the Conditional Probability

$$
\begin{align*}
& \operatorname{Pr}\left(A_{i}, B_{j}\right)=\operatorname{Pr}\left(A_{i} \mid B_{j}\right) \operatorname{Pr}\left(B_{j}\right)  \tag{3}\\
&=\operatorname{Pr}\left(B_{j} \mid A_{i}\right) \operatorname{Pr}\left(A_{i}\right)  \tag{4}\\
& \sum_{i=1}^{a} \sum_{j=1}^{b} \operatorname{Pr}\left(A_{i}, B_{j}\right)=1 \tag{5}
\end{align*}
$$

## Marginal Probability

Marginal Probability

$$
\begin{align*}
\operatorname{Pr}\left(A_{i}\right) & =\sum_{j=1}^{b} \operatorname{Pr}\left(A_{i}, B_{j}\right)  \tag{6}\\
& =\sum_{j=1}^{b} \operatorname{Pr}\left(A_{i} \mid B_{j}\right) \operatorname{Pr}\left(B_{j}\right)  \tag{7}\\
& \sum_{i=1}^{a} \operatorname{Pr}\left(A_{i}\right)=1 \tag{8}
\end{align*}
$$

## Proof of Bayes Theorem

Bayes Theorem

$$
\begin{equation*}
\operatorname{Pr}\left(B_{j} \mid A_{i}\right)=\frac{\operatorname{Pr}\left(A_{i} \mid B_{j}\right) \operatorname{Pr}\left(B_{j}\right)}{\sum_{j=1}^{b} \operatorname{Pr}\left(A_{i} \mid B_{j}\right) \operatorname{Pr}\left(B_{j}\right)} \tag{9}
\end{equation*}
$$

proof
By Eq.(4), we have

$$
\begin{equation*}
\operatorname{Pr}\left(B_{j} \mid A_{i}\right)=\frac{\operatorname{Pr}\left(A_{i}, B_{j}\right)}{\operatorname{Pr}\left(A_{i}\right)} \tag{10}
\end{equation*}
$$

However, by Eq. $(3), \operatorname{Pr}\left(A_{i}, B_{j}\right)=\operatorname{Pr}\left(A_{i} \mid B_{j}\right) \operatorname{Pr}\left(B_{j}\right)$ and by
Eq. (7), $\operatorname{Pr}\left(A_{i}\right)=\sum_{j=1}^{b} \operatorname{Pr}\left(A_{i} \mid B_{j}\right) \operatorname{Pr}\left(B_{j}\right)$

## Bayes Theorem (alt)

Bayes Theorem

$$
\begin{align*}
\operatorname{Pr}\left(B_{j} \mid A_{i}\right) & =\frac{\operatorname{Pr}\left(A_{i} \mid B_{j}\right) \operatorname{Pr}\left(B_{j}\right)}{\operatorname{Pr}\left(A_{i}\right)}  \tag{11}\\
& =\frac{\operatorname{Pr}\left(A_{i}, B_{j}\right)}{\operatorname{Pr}\left(A_{i}\right)}  \tag{12}\\
& \propto \operatorname{Pr}\left(A_{i}, B_{j}\right)=\operatorname{Pr}\left(A_{i} \mid B_{j}\right) \operatorname{Pr}\left(B_{j}\right) \tag{13}
\end{align*}
$$

Left-hand side is the conditional probability of $B_{j}$ given $A_{i}$.
Therefore, it must satisfy

$$
\begin{equation*}
\sum_{j=1}^{b} \operatorname{Pr}\left(B_{j} \mid A_{i}\right)=1 \tag{14}
\end{equation*}
$$

Therefore

$$
\begin{equation*}
\operatorname{Pr}\left(B_{j} \mid A_{i}\right)=\frac{1}{\sum_{j=1}^{b} \operatorname{Pr}\left(A_{i}, B_{j}\right)} \operatorname{Pr}\left(A_{i}, B_{j}\right) \tag{15}
\end{equation*}
$$

## Normalization

Given the Joint probability $\operatorname{Pr}\left(A_{i}, B_{j}\right)$, the conditional probability $\operatorname{Pr}\left(B_{j} \mid A_{i}\right)$ can be calculated by normalizing the joint probability.

## Interpretation of Bayes Theorem

Cause and Effect Interpretation of Bayes Theorem
Let $A_{i}, i=1,2, \ldots, a$, be the possible effects, and
$B_{j}, j=1,2, \ldots, b$, be the possible causes. That is, the result of an experiment can be interpreted as the effect $\times$ cause two-way classification.
Let $\operatorname{Pr}\left(A_{i} \mid B_{j}\right)$ be the conditional probability of $A_{i}$ given $B_{j}$, and $\operatorname{Pr}\left(B_{j}\right)$ be the prior probability of $B_{j}$.
Then, the Posterior (or inverse) probability of $B_{j}$ given $A_{i}$ can be given as

$$
\begin{equation*}
\operatorname{Pr}\left(B_{j} \mid A_{i}\right)=\frac{\operatorname{Pr}\left(A_{i} \mid B_{j}\right) \operatorname{Pr}\left(B_{j}\right)}{\sum_{j=1}^{b} \operatorname{Pr}\left(A_{i} \mid B_{j}\right) \operatorname{Pr}\left(B_{j}\right)} \tag{16}
\end{equation*}
$$

$\operatorname{Pr}\left(A_{i} \mid B_{j}\right)$ is called the Model probability or the Likelihood.

## Posterior Probability

- The Joint probability is the product of the Model probability (CPT or Likelihood) and the Prior probability.
- The Posterior probability is proportional to the Joint probability.
- Therefore, the Posterior probability is proportional to the product of the Model probability (CPT or Likelihood) and the Prior probability.

Conditional Probability Table
CPT:

When $A_{i}, i=1,2, \ldots, a$, are mutually exclusive and exhaustive,

$$
\sum_{i=1}^{a} \operatorname{Pr}\left(A_{i} \mid B_{j}\right)=1
$$

That is, the culumn sum of $\mathrm{CPT}=1$.

## Joint Probability

Note that $\operatorname{Pr}\left(A_{i}\right)$ can be given as the row sum:

$$
\operatorname{Pr}\left(A_{i}\right)=\sum_{j=1}^{b} \operatorname{Pr}\left(A_{i} \mid B_{j}\right) \operatorname{Pr}\left(B_{j}\right)
$$

The sum of the joint probabilites $=1$.

## Posterior Probability

Table of the Posterior probability $\operatorname{Pr}\left(B_{j} \mid A_{i}\right)$

Normalize the Joint probability by dividing its row sum: $\operatorname{Pr}\left(A_{i}\right)$.

$$
\sum_{j=1}^{b} \operatorname{Pr}\left(B_{j} \mid A_{i}\right)=1
$$

## ST or SW (revisited)

- We know that:

90\% of the ST fans likes Tea, 30\% of the SW fans likes Tea.
And
the ratio of ST fans vs SW fans = 1:9.

- What is the probability that a person is a ST fan if we find out that he/she likes Tea?
- A1=Tea, A2=not Tea =coffee, B1 $=$ SW, $\quad B 2=S T$


## ST or SW (CPT)

- Conditional Probability Table

$$
\text { Conditional Probability } \mathrm{P}(\mathrm{~A} \mid \mathrm{B})
$$

tea coffee

| sw | st |  |
| :--- | ---: | ---: |
|  | $\mathrm{P}(\mathrm{A} \mid \mathrm{B} 1)$ | $\mathrm{P}(\mathrm{A} \mid \mathrm{B} 2)$ |
| A1 | 0.3 | 0.9 |
| A2 | 0.7 | 0.1 |
| sum | 1 | 1 |

Prior Probability of $B P(B)$


## ST or SW (joint probability table)

- Joint Probability Table
joint prob $=$ Model prob $\times$ prior

|  | Joint Probability P(A,B) |  |  | Marginal Pr |
| :---: | :---: | :---: | :---: | :---: |
|  |  | sw | st |  |
|  |  | B1 | B2 | $\mathrm{P}(\mathrm{A})$ |
| tea | A1 | 0.27 | 0.09 | 0.36 |
| coffe | A2 | 0.63 | 0.01 | 0.64 |
|  | P(B) | 0.9 | 0.1 | 1 |

## Popular Examples of Bayes Theorem

- Simple Problems

Smoker Testing, Coin Toss

- Three Prisoners Problem and its variations normal and pathological CPT
- Monty Hall Problem patholosical CPT


## Smoker Test Problem

- A blood test correctly detects smoker with probability $90 \%$ but gives a positive result for the non-smokers with probability 30\%.

Assume that 50\% of the population smokes.
What is the probability that a person tested is a smoker given the positive result?

## Coin Toss Problem

- A coin was tossed and we observed a Head. Was the coin fair?
- A1=Head, A2=Tail
$B 1=c o i n$ is Fair, $B 2=c o i n$ is not Fair
- CPT:
$\operatorname{Pr}($ Head $\mid$ Fair $)=1 / 2$
$\operatorname{Pr}($ Head $\mid$ unFair $)=2 / 3$
- Marginal Prob
$\operatorname{Pr}($ FairCoin $)=1 / 2$


## Three Prisoners Problem (normal CPT)

- There are three prisoners, A, B, and C, one of whom will be released and the other two executed.

Prisoner A overhears that the warden say that prisoner B will be executed.

Assuming the warden's truthfulness, there are now only two possibilities for who will be executed: A or C.

Does prisoner A gain any information as to his own fate, that is, does he change his estimate of the chances he will be released?

## Three Prisoners Problem

- There are three prisoners, A, B, and C, one of whom will be released and the other two executed.

> Prisoner $A$ asks the warden to tell him the name of one of the others(B or $C$ ) who will be executed. As the question is not directly about A's fate, the warden obliges and answers that B will be executed.

Assuming the warden's truthfulness, there are now only two possibilities for who will be executed: A or C.
Does prisoner A gain any information as to his own fate, that is, does he change his estimate of the chances he will be released?

## Monty Hall Problem

- Suppose you're on a game show, and you're given the choice of 3 doors:
Behind one door is a car;
behind the other 2 doors, goats.
You will get whatever behind the door you choose.
You pick a door, say "A", and the host, who knows what's behind the doors, opens another door, say " $B$ ",
which has a goat. He then says to you, "Do you want to pick door "C" ?"

Is it to your advantage to switch your choice? (Let's Make a Deal: 1963-1976 on US network TV)

## Solution of Monty Hall Problem

- Let

A1=Host opens door A.
A2=Host opens door B.
A3=Host opens door $C$.

B1=Car is behind door $A$ and you pick door $A$. $B 2=$ Car is behind door $B$ and you pick door $A$. $B 3=$ Car is behind door $C$ and you pick door $A$.

- Let

$$
\operatorname{Pr}(\mathrm{B} 1)=\operatorname{Pr}(\mathrm{B} 2)=\operatorname{Pr}(\mathrm{B} 3)=1 / 3
$$

## Test Scores

- A student can be classified as L, M, or H according to his/her ability.

The CPT of a five item test score given ability level is known.

Also, $\operatorname{Pr}(\mathrm{L}), \operatorname{Pr}(\mathrm{M})$ and $\operatorname{Pr}(\mathrm{H})$ are known.

- Given the test score ( $0-5$ ) how do we classify the student?


## Solution

Let $A_{i}$ be "test score $=i-1$ " and

$$
B_{1}=\mathrm{L}, \quad B_{2}=\mathrm{M}, ~ B_{3}=\mathrm{H} .
$$

Also, we know that $\operatorname{Pr}\left(B_{1}\right)=\operatorname{Pr}\left(B_{3}\right)=0.25, \operatorname{Pr}\left(B_{2}=.5\right)$.

Note that the posterior odds of not Fiar to Fair, given Head, is larger with this example.
$\frac{\operatorname{Pr}(\text { not Fair } \mid \text { Head })}{\operatorname{Pr}(\text { Fair } \mid \text { Head })}=\frac{.571}{.429}=1.333<1.778=\frac{.640}{.360}=\frac{\operatorname{Pr}(\text { not Fair } \mid \text { Head, Head })}{\operatorname{Pr}(\text { Fair } \mid \text { Head, Head })}$
Note also that, $\operatorname{Pr}($ Fiar $\mid$ Head,Tail $)=\operatorname{Pr}($ Fiar $\mid$ Tail, Head $)$.
Nunber of Heads is sufficient for the inference.

Note that, with this example (CPT) the sum of two test scores is not sufficient. For example the posterior probability of B given sum $=6$ are shown below.
